College Scholarship Program: In 2017, the Daniel Trust Foundation awarded \$23,000 in college scholarships to 41 returning and new students in the Foundation's College Scholarship Program. Some of our College Scholars attend some of the best colleges and universities in the United States including Harvard University, Yale University, UC Berkeley, and The University of North Carolina at Chapel Hill. The Daniel Trust Foundation Scholarship is a 4-year \$2,000 scholarship. Recipients receive \$500 per year to help them pay for their college textbooks and other school supplies. Since 2014, the Foundation has awarded over \$46,000 in college scholarships.

High School Mentoring Program: 12 juniors and 12 seniors participated in our weekly Saturday classes where they received help with: SAT Prep College Essays, College and Financial Aid Applications, Resume, Job Search and Applications, Financial Literacy 101, and Teen Driving Education. 100% of the seniors in the program graduated high school and were accepted and are currently attending a 2-year community college or a 4-year university. The 12 juniors in the program became seniors in the Fall of 2017 and are on track to graduate in June 2018.

Teacher Recognition Program: 12 teachers were honored at The 4th Annual Daniel Trust Awards and were awarded with \$2,750 in honorarium. One of the things that makes the Daniel Foundation unique is that, when students receive our scholarship, they get to honor an educator or a teacher who has made a big difference in their lives. Since 2014, the Foundation has honored 35 teachers and has awarded over \$11,000 in teacher honorariums to help supplement out of pocket expenses.
