High School Mentoring Program: 12 juniors and 7 seniors participated in our weekly Saturday classes where they received help with: SAT Prep College Essays, College and Financial Aid Applications, Resume, Job Search and Applications, Financial Literacy 101, and Teen Driving Education. 100% of the seniors in the program graduated high school and were accepted and are currently attending a 2-year community college or a 4-year university. The 12 juniors in the program became seniors in the Fall of 2016 and are on track to graduate in June 2017.

4b (Code:) (Expenses \$ **13,900.** including grants of \$) (Revenue \$)

College Scholarship Program: 29 students (14 returning and 15 new) received our college scholarship. Our scholars are attending some of the best colleges in the US including Harvard University, UC Berkeley, Yale University, Boston College, American University, UNC-Chapel Hill, Fairfield University, University of Connecticut, Southern Connecticut State University, University of Bridgeport, Central Connecticut State University, North Carolina Wesleyan University and Howard University. Since 2014, the Foundation has awarded over \$25,000 in college scholarships. The Daniel Trust Foundation Scholarship is a 4-year \$2,000 scholarship. Recipients receive \$500 every school year to help pay for college textbooks and supplies.

Teacher Recognition Program: 14 teachers were honored at the 3rd Annual Daniel Trust Awards and were awarded with \$3,250 in honorarium. One of the things that makes the Daniel Foundation unique is that, when students receive our scholarship, they get to honor an educator or a teacher who has made a big difference in their lives. Since 2014 the Foundation has honored 23 teachers and has awarded over \$8,000 in teacher honorarium to help supplement out of pocket expenses.
